


The District of Columbia Boat Titling Act of 1983 requires that, beginning March 14, 1984, any vessel principally used on District of Columbia waters and required to be registered shall have a certificate of title issued by the Harbor Master prior to issuance or renewal of a registration number. The application for a certificate of title must be accompanied by:

- NEW VESSEL:** 1. A manufacturer's Certificate of Origin issued by the dealer at the time of purchase.
- USED VESSEL:** 1. A notarized invoice stating gross purchase price, date of purchase, and a description of the watercraft.
2. Proof of purchase if the watercraft was registered in another state, or a signed transfer from the registered owner if previously registered in the District of Columbia.
